DECLARATION OF BRONYN HEUBACH ON NOTICE PLAN AND SETTLEMENT ADMINISTRATION

I, Bronyn Heubach, hereby declare and state as follows:

1. I am an Assistant Director at JND Legal Administration. JND is a legal administration services provider with its headquarters located in Seattle, Washington. JND has extensive experience in all aspects of legal administration and has administered class actions in hundreds of cases.

2. JND is serving as the Settlement Administrator in the above-captioned litigation (the "Action") pursuant to the Court's Order Granting Plaintiffs' Motion for Preliminary Approval of Class Action Settlement, filed April 4, 2023 (ECF 86).

3. This Declaration describes the implementation of the Notice Plan, as described in the Settlement Agreement, filed December 20, 2022 (ECF 78-1) and provides an update on the claims administration process. The Notice Plan was designed to inform Class Members of the proposed Settlement and their rights and options.

CAFA NOTICE

4. On December 30, 2022, on behalf of Defendants Türk Hava Yollari A.O. (d/b/a Turkish Airlines) and Turkish Airlines, Inc. ("Defendants"), JND mailed notice of the Turkish Airlines Settlement to the United States Attorney General and to the appropriate State officials pursuant to Class Action Fairness Act of 2005.

DIRECT NOTICE

Class Member Identification

5. On April 14, 2023, Defendants provided JND with class data containing the names, ticket reservation numbers, and contact information for potential Class Members.

6. Despite Defendants' best efforts, many records were missing contact information that would allow JND to send the Notice either by mail or email. For records with phone numbers, JND conducted advanced address research to look up email and mailing addresses. JND then analyzed, de-duplicated, and standardized the data and identified 247,682 unique potential Class Member records.

7. JND promptly loaded these records into a secure, case-specific database for the Settlement. A unique identification number ("Unique ID") was assigned to each Class Member to identify them throughout the administration process.

Direct Email Notice

8. On May 18, 2023, JND commenced sending the Email Notice to all potential Class Members for whom JND obtained at least one valid email address. The Email Notice completed sending on June 5, 2023. The Email Notice included the potential Class Member's Unique ID and PIN to facilitate logging in to the online claim portal and filing a claim electronically. The Email Notice contained links to the Settlement Website, deadlines to object, request exclusion, and

submit a Claim Form, the date of the Fairness Hearing, and Settlement Administrator contact information. A representative copy of the Email Notice is attached as Exhibit A.

9. In total, JND sent a total of 179,982 Email Notices to 154,711 unique Class Members, of which 6,893 emails bounced back and were not deliverable.

Direct Mail Notice

10. JND supplemented the Email Notice effort by sending a Summary Notice ("Postcard Notice") to all potential Class Members for whom an Email Notice was undeliverable, or for whom a valid email address was not obtained. The Postcard Notice included the potential Class Member's Unique ID and PIN to facilitate logging in to the online claim portal and filing a claim electronically. The Postcard Notice contained the URL for the Settlement Website, deadlines to object, request exclusion, and submit a Claim Form, the date of the Fairness Hearing, and Settlement Administrator contact information. JND mailed the Postcard Notices on June 16, 2023 to 14,091 potential Class Members. A representative copy of the Postcard Notice is attached as Exhibit B.

Reminder Email Notices

11. On June 16, 2023, a reminder Email Notice campaign commenced to all potential Class Members with at least one valid email address. Email addresses that were undeliverable in the initial Email Notice campaign were not included. A total of 175,591 emails were sent to 151,655 unique Class Members, of which 7,216 bounced back. A representative copy of the reminder Email Notice is attached as Exhibit C.

INDIRECT PUBLICATION NOTICE

12. In order to reach as much of the Class as possible, JND supplemented the Direct Notice effort with indirect noticing efforts, including digital media, a press release, an internet search campaign, and sponsorships on popular class action websites.

13. The combined reach for the direct email notice and digital effort is 83%. While not measurable, the internet search campaign, press release, and two class action sponsorships (i.e., TopClassActions.com and ClassActions.org) extended reach further.

Digital Notice Campaign

14. On May 18, 2023, JND launched a four-week digital ad campaign through the Google Display Network ("GDN"), Facebook/Instagram, and Twitter, consisting of 117 million digital impressions designed to reach potential Class Members using multiple targeting strategies. The digital ads included an embedded link to the Settlement Website, where potential Class Members could get more information about the Settlement and file a claim online.

15. As of the date of this Declaration, a total of 126,076,651 impressions (i.e. display of the ad on a search result page or other site on the Google Network) were delivered through GDN, Facebook/Instagram, and Twitter, which resulted in 15,455 clicks. Copies of representative digital ads are attached as Exhibit D.

Internet Search Campaign

16. On May 18, 2023, JND implemented an internet search campaign to assist potential Class Members with locating the Settlement Website. JND purchased ads tied to keywords related to the Settlement so when those terms were searched, an advertisement with a hyperlink to the Settlement Website would appear on the results page.

17. As of the date of this Declaration, a total of 13,655 impressions were delivered through keyword searches, resulting in 1,071 clicks.

Press Release and Class Action Site Sponsorships

18. To further assist in getting "word of mouth" out about the Settlement, JND distributed a press release through PR Newswire which reaches over 15,000 media outlets (English and Spanish) nationwide. A copy of the press release is attached as Exhibit E.

19. Certain class action websites are frequented for updates on class action lawsuits. These sites help drive potential Class Members to the official settlement websites by featuring sponsored actions in a prominent area on the sites' home pages and providing additional details on pages specific to the individual settlements. JND provided notice of the Settlement through sponsorship opportunities with TopClassActions.com and ClassAction.org. Screenshots of our sponsored features through TopClassActions.com and ClassAction.org are attached as Exhibit F.

SETTLEMENT WEBSITE AND OTHER CLASS MEMBER NOTICE

Settlement Website

20. On May 15, 2023, JND launched an interactive, case-specific Settlement Website at www.TASettlement.com, and this URL was listed in the Direct Notices. The Website provides comprehensive information about the Settlement, including answers to frequently asked questions, contact information for the Settlement Administrator, key dates, and links to important case documents, including the Long Form Notice, the Summary Notice, the Claim Form, and the Settlement Agreement.

21. The Settlement Website also features an online Claim Form for the submission of claims. Additionally, as noted above, a Claim Form is posted on the Settlement Website for download for those Class Members who prefer to submit a Claim Form by mail.

22. As of the date of this Declaration, the Settlement Website has tracked a total of 35,954 unique users who registered 140,825 page views. JND will continue to update and maintain the Settlement Website throughout the settlement administration process.

Settlement Administrator Toll-Free Number

23. On May 15, 2023, JND launched a 24-hour, toll-free information line that Class Members can call to obtain pre-recorded information about the Settlement.

24. As of the date of this Declaration, JND has received 737 calls to the toll-free number. JND will continue to maintain and update the toll-free number throughout the settlement administration process.

Settlement Administrator Post Office Box

25. JND established a post office box, Turkish Airlines Settlement, c/o JND Legal Administration, PO Box 91455, Seattle, WA 98111, to administer the Settlement to receive Class Member correspondence, paper Claim Forms, exclusion requests, and objections.

CLAIMS RECEIVED

26. The Notices informed Class Members they may file claims electronically through the Settlement Website. Class Members who do not wish to submit their claim online may download and print a Claim Form from the Website or request a mailed copy of the Claim Form by writing the Settlement Administrator. The deadline to file claims is August 18, 2023.

27. As of the date of this Declaration, JND has received a total of 8,886 Claim Forms. JND continues to receive and process Claim Form submissions and will continue to report to Counsel on the status of the claim intake and review.

OBJECTIONS

28. The Notices informed recipients that any Class Member who wanted to object to the proposed Settlement could do so by submitting a written statement on or before July 17, 2023.

29. As of the date of this Declaration, JND has received one (1) objection. A copy of the objection is attached as Exhibit G. JND will promptly report to Counsel any additional objections that are received.

REQUESTS FOR EXCLUSION

30. The Notices also informed Class Members of their right to opt out of the Settlement by submitting a written request for exclusion. The deadline to opt out is July 17, 2023.

31. As of the date of this Declaration, JND has received twenty-four (24) requests for exclusion. A list of exclusion requests is attached as Exhibit H. JND will promptly report to Counsel any additional exclusion requests that are received.

What's Going On?

Turkish Airlines has agreed to settle a class action lawsuit that claimed the airline <u>failed</u> to properly refund customers for flights canceled because of the COVID-19 pandemic. According to the suit, Turkish Airlines either provided no refund at all or failed to refund customers within a reasonable amount of time.

Who's Eligible for the Settlement?

The settlement covers **United States** residents who purchased tickets for travel to, from, or within the United States between March 1, 2020 and December 31, 2021 and whose flight was canceled by Turkish

Airlines. The settlement does not include customers who canceled their flights themselves, failed to show up for the first leg of a flight that was later canceled, already received a voucher or rebooking from Turkish Airlines, or already received a chargeback from their credit card provider for the canceled flight.

How Much Could I Get?


Customers who already received a refund from Turkish Airlines can file a claim for either **\$10 cash or a \$45 voucher** to use on future Turkish Airlines flights. These amounts could potentially be reduced if the total value of the cash and voucher claims exceeds \$1 million.

Customers who have not received a refund from Turkish Airlines can file a claim to receive a refund of 101% of their unused ticket price.
